# PREVIOUS MINUTES

#### 1.0 MEETING MINUTES | EXECUTIVE COMMITTEE REPORTS

President's Report – Tony Finch

The President relayed his pride in the growth and expansion of the Club – on and off the pitch – specifically the clubs effort to support the signing of the Armed Forces Covenant and the welcoming of Ashford Ladies RFC and Leuven Ladies RFC to our club ACTION

Treasurer's Report – Jason Potter

Accounts presented to the meeting (which are available alongside these minutes) The Club ran at a loss due partly because of a lack of bar income as the club does not possess its own self-managed bar facilities. The club still has an outstanding debt with Ball Contractors for material costs when the Club was originally took over and refurbished The Ridge. This has been reduced by approx£5k, £2500 remains outstanding.

As highlighted during last year's AGM, JP presented far more detailed account reports

The Committee in general asked that the Club's appreciation for Jason Potter's excellent work in the Treasurer's role be minuted.

Membership Office – Jason Potter

JP stated that there was a considerable improvement over the year before in terms of cooperation but stated that there are a few members who haven't been charged as they joined midway

#### Captain – Jason Potter

JP stated that it has been an up and down season plagued by injury and some difficulty with availability. Two big wins over teams like Thanet and Whitstable were massive highlights. Excitement over the new players coming to the club and stressed the importance of commitment to the club in the coming season. He players who committed as much as possible

Sponsorship Officer – Matthew Ball

MB stated much help from PW in terms of producing professional sponsorship packs and the high profile of the club has given itself through social media, sponsorship packages etc.

As has been the case in previous years first refusal is offered to the

incumbent sponsors and French Forrest Flooring have stated that they wish continue as our main sponsor

Announced that Mitsubishi are sponsoring us next year and thanks was given to the club in general from the committee for making the Mitsubishi representative as welcome as we did on the day he attended one of our matches. The club was appreciative that Folkestone RFC pointed Ashford Orbital/Mitsubishi in our direction.

Last year we raised over £3000 in sponsorship money

Hon. Secretary – Marc Turley

MT expressed that whilst not having much to update the club members with in terms of news and development, he as thoroughly enjoyed being more involved with how the clubs is run

Fixtures Secretary – James Hall

JH did not attend the AGM and advised the committee prior that he wished to step down from the role of Club Fixtures Secretary

Coaches – Chris Dale and Tim Cross

Thanks from coaches for the effort made by players. Also stressed the importance of commitment and the disappointment that some training sessions had been cancelled and stressed how important this commitment is. Summarised as such a 'nearly' season for us

#### Other notes –

Raised that we were discussing the year prior accounts (2015 - 16) rather than last seasons (2016-17) and that we are considering running a long or short year so that the accounts are in sync with each committee meeting.

Raised that sometimes the lack of support for the after game meal isn't great and that obviously when it isn't eaten, it is wasted. It's important that as a club, we encourage people to make the most of the facilities that are put on.

All ABRFC Executive & Honorary Committee roles declared vacant.

9.0	Club facilities – MB (with support from a few others) has been working to try and secure us a more permanent venue. MB and TC working to try and secure us this and is working through the motions with the council, relevant authorities and governance to do this properly.
10.0	RFU Course – MB advised on the benefit of the course he attended and the benefits it has brought to the club. He would like two club members to attend next year
11.0	Armed Forces Covenant – The clubs aims to promote the covenant on a wider scale by working with other clubs to make this work to our advantage as much as possible. This is to maximise the clubs profile in the local and rugby community.
